## INSTRUCTIONS:

1. The camper agrees to pay to the Eastern Idaho State Fair (EISF), rent for the site in the amount of **\$270.00 (two hundred seventy dollars & no/100 - -)** for CAMP SITE with water and power hook ups. The minimum of \$135.00 deposit will be due by **MARCH 24, 2023, with signed Reservation Form and Policy and Regulation Form** and final payment by **JUNE 23, 2023**, mail to: EISF, PO Box 250, BLACKFOOT, ID 83221. Campsite reservation will not be held if deposit not received by April 15, 2023, we have a list of campers wanting a space and will be unable to hold spots past this date.
2. Make checks payable to "EASTERN IDAHO STATE FAIR", once your reservation is confirmed, there will be **NO** refund for any reason.
3. The camper agrees to use the premises for camping only and does certify that the site cannot be sublet without prior permission from the Fair.
4. The camper agrees to read and comply with all the campground "POLICIES AND REGULATIONS" as typed on the second page of rental agreement and ANY posted rules or regulations at campground.
5. RV Parking Permit (1) and RV Vehicle Parking Permit (1) will be mailed to above address by **AUGUST 1, 2023--EXCEPT** Vendors - Vendor RV Permits will be in packages and available at Check-In at EISF Main Office.
6. Permits **MUST** be displayed in front facing window/area and will be checked on daily basis (duplicate RV Parking Permits or RV Vehicle Parking Permits will not be issued by EISF).
7. **Check in on MONDAY, AUGUST 28, 2023 and check out will be MONDAY, SEPTEMBER 11, 2023, (additional fee of \$30.00 for any additional days)**

# EASTERN IDAHO STATE FAIR RV PARK POLICIES AND REGULATIONS

The following policies apply to EASTERN IDAHO STATE FAIR RV PARK AND ANEX AREAS:

1. Speed Limit is 3 mph!
2. **NO PARKING IN ROADWAYS.**
3. **NO ADDITIONAL VEHICLES WILL BE ALLOWED IN CAMPGROUND WITHOUT A PARKING PERMIT.**
4. **Pets must remain on a leash, no longer than eight (8) feet, at all times. Pet handlers must remove & properly dispose of all waste from pets. PETS ARE NOT ALLOWED INSIDE FAIRGROUNDS, UNLESS CERTIFIED SERVICE ANIMAL, see Pet Policy in EISF General Rules.**
5. **No fireworks are allowed in the RV Park. Hunting or the use of firearms, bow and arrow, air or gas weapon, or other projectile devices capable of injuring or killing any person or animal or damaging or destroying any park property are prohibited.**
6. **Persons under 18 years of age must be accompanied by a parent or guardian to camp overnight.**
7. **All trailers, including awnings and hitches, and ANY vehicles must fit in assigned area, no encroaching onto other campsites or into driveways. MAXIMUM LENGTH 38 FEET AND MAXIMUM WIDTH 14 FEET**
8. **Parking permit with number visible MUST be displayed in trailer and tow vehicle front facing window/area, at all times.**
9. **Parking of additional vehicles, allowed in designated areas only, permit required. (fee may apply) Permit must be visible at all times.**
10. **Only one (1) self-contained camping vehicle is allowed per campsite.**
11. **To show occupancy, a vehicle or tent must remain in the site at all times. If you plan to leave the campsite during your reservation period, make certain the campsite appears occupied. If the campsite looks empty, EISF is not responsible for loss.**
12. **Open fires are not permitted, Do not place hot grills or other hot appliances on ground.**
13. **Quiet hours are from 11:00 p.m. until 7:00 a.m., this includes generators, radios, TV's, loud voices, barking or whining of animals or running vehicles will NOT be allowed during Quite Time hours. Noise must not emit past the assigned camping area.**
14. **Lights out from midnight to 6:00 a.m.**
15. **Trash must be removed & disposed of in large dumpster on south side of main trailer park daily. Not in garbage cans, located in roadways.**
16. **Trailer site it to be clean and orderly at all times and cleaned at completion of stay, if violation happens, violators will not be allowed to return to campsite following year.**
17. **No reserving or saving of pavilion. Pavilion is for paying campers only.**
18. **NO GREY WATER dumped on the ground; trailers will be removed at owner's expense if violation occurs.**
19. **Showers are for paying renters only, they are to be kept in clean and orderly fashion. NO PETS OF ANY KIND ALLOWED IN RESTROOMS OR SHOWER AREA.**
20. **All visitors not camping overnight must leave the park by 11:00 p.m.**
21. **Spaces are assigned, DO NOT park in any other space. Trailer or vehicle will be towed at owner's expense and will forfeit the right to rent any type of RV Spot in subsequent years.**
22. **E.I.S.F. will NOT be held liable for ANY damage to ANY vehicle that must be towed to comply with any rule, policies or regulations.**

## HOLD HARMLESS DISCLAIMER:

- Camper agrees to carry his or her own liability and comprehensive insurance and vehicle registration during the term of this rental period on their trailer.
- This rental agreement contains the entire agreement between the fair and camper. No other representation or inducement, verbal or written, has been made which is not contained in this rental agreement. This agreement is severable, if one portion is invalid, the remaining portion will, never less, remain in full force and effect.
- It shall be within the authority of the Fair Manager, or their representative, to remove from the Park any or all members of a group whose behavior, at any time, conflicts with County or State laws, becomes detrimental to the health and safety of the group or other Park users, or becomes so unruly as to affect the reasonable enjoyment of the Park by other users
- The camper accepts camping privileges with the understanding that he or she does hereby release Eastern Idaho State Fair, its officers, volunteers, fellow campers and employees of all liability for the loss or damages to any property and injury to his/her person arising out of his/her use of its camping facilities and agrees to indemnify the campground, its officers, volunteers, fellow campers and employees, against claims resulting from loss or damage to property or injury to the person(s) or visitor(s) of any member of the family of the camper, arising out of the use of its camping facilities and any activities, games, or events sponsored by Eastern Idaho State Fair.
- I agree to pay for any damages to campground property, sites, buildings, facilities, equipment, or loss of equipment, which may occur. I also agree to immediately report any accident, injury or property damage to the manager or staff. If a hazard or dangerous situation exists on the premise, the said camper will notify the management or staff immediately.
- I also agree to take full responsibility for myself and all people in my party, including minors and visitors, and will require them to read and comply with all campground rules and regulations as posted in the office or on the grounds, as well as the terms and conditions as set forth in this registration form.
- I accept full responsibility for my children or those children in my care, custody or control, and will supervise and attend to my children at all times while on these premises.
