### GENERAL RULES:

- Only 20 Positions will be drawn, plus 2 Alternates
- ***EACH MUTTON BUSTIN' PARTICIPANT AND ONE (1) HELPER WILL RECEIVE A WRISTBAND FOR THE CHUTE AREA AND A GEM STATE CLASSIC PRO RODEO TICKET (TOTAL 2). MUTTON BUSTIN PARTICIPANTS CAN PURCHASE UP TO FOUR (4) ADDITIONAL RODEO TICKETS AT A DISCOUNTED RATE OF \$15.00 EACH, AND THESE ARE TO BE PICKED UP AND PAID FOR AT EISF MAIN OFFICE AFTER TUESDAY, AUGUST 20, 2024. GEM STATE CLASSIC PRO RODEO TICKETS WILL BE FOR TUESDAY, SEPTEMBER 3, 2024, AND WILL BE IN SECTION 1. SEATS WILL BE LOCATED IN ROWS L THROUGH S. THERE WILL NOT BE ANY CHOOSING OF SPECIFIC SEATS, BUT SEATS WILL BE TOGETHER. TICKETS MUST BE REQUESTED ON THE ENTRY FORM. NO CHANGES TO AMOUNTS AFTER DRAWING.***
- Child must be between the ages of 4 and 7 as of September 1, 2024, and MUST weigh less than forty-five (45) lbs.
- Rider may use a rope (PUT ON BY COMMITTEE ONLY) or take a wool hold.
- Child may use one or two hands, with one-hand rides receiving more points.
- Child must ride for six (6) seconds to score and receive points.
- Sheep shall be chute run, with two (2) contestants per chute.

### REQUIREMENTS:

- HELMETS ARE REQUIRED TO BE WORN BY ALL PARTICIPANTS – helmets provided by Gem State Classic Rodeo.
- ONE HELPER PER CONTESTANT WILL BE ALLOWED IN THE CHUTE AREA.
- HELPERS AND CONTESTANTS MUST DRESS WESTERN (long-sleeve shirt, western boots, etc.)
- NO SPURS ALLOWED.
