**PREMIUM CHECKS:** Will not be available until (2) two hours after completion of event. No premium checks will be issued early. A W-9 will need to be provided, prior to release of checks.

## **SPECIAL DEPARTMENT RULES:**

- A. All entry fees must be paid before event. All entry money over stock charge will go toward prizes and purse money. Rosettes will be awarded for 1st; 2nd; and 3rd place team as well as buckles for the First-place team in the Penning, Sorting and Open Branding and to the Amateur on the first and second place teams in the Pro/Am Division.
- B. Every County that holds an open team sorting, open branding or open penning event will be eligible to send one (1) team per event to the E.I.S.F. For Bonneville and Bannock Counties that have (2) county fairs, (2) qualifying teams will be allowed.
- C. All counties that have qualifying teams must send names, address and phone numbers no later than **August 16, 2024**, to: Steve Oyler

- D. All other Team Penning, Sorting and Branding teams in the open division will be picked from qualified teams competing in a FULL DRAW SYSTEM from members that are eligible (fully paid) from the Eastern Idaho Team Penning and Branding Association. All Pro/Am Team Branding teams will be by pick teams only (no draw) of 4 team members.

- E. Each team must have at least one (1) rider that is an Idaho resident competing.
- F. Any person wishing to bid on supplying cattle must call Steve Oyler at 208-251-2661 before August 1st. Cattle must be fresh and have not been used in any other event in the last 60 days. Contractor will be responsible for any injury to cattle.
- G. No team can represent the same qualifying event more than once.
- H. Any contestant verbally harassing any official or volunteer appointed by the Superintendent will be banned from future shows.
- I. All contestants must sign a "**EISF PERSONAL RELEASE FORM**" prior to being able to compete.
- J. Only trucks and trailers with horses are allowed to park on the infield for these events and **ALL VEHICLES AND STOCK MUST BE REMOVED FROM INFIELD PRIOR TO 5:00 P.M.** No Exceptions. Cars will not be permitted to park on the infield.
- K. Maximum of 16 teams to compete in each class.

**HEALTH POLICY:**

- A. All out of state entries must be accompanied by a Health Certificate. All out of state entries must be accompanied by a Health Certificate. Out-of-state horses must have a health certificate and a negative Coggin's test within the last 6 months. Copy of current Health Certificate must be provided to Livestock Office on entry to the fairgrounds. \*\*Any livestock (equine, bovine, porcine, caprine, ovine, or cervidae) entering Idaho from a premises where vesicular stomatitis has been diagnosed within the last thirty (30) days shall be accompanied by a certificate of veterinary inspection dated within fourteen (14) days of entry containing the following statement: "All animals identified on this certificate of veterinary inspection have been examined and found to be free from Vesicular Stomatitis. During the last thirty (30) days, these animals have neither been exposed to VS nor located within an area where VS has been diagnosed."
- B. Vaccinate all horses coming to the EISF against the Equine Herpes Virus (Rhino). It comes in a 2-way vaccine that is inexpensive and effective, Pneumabort K is one example that has proven to help prevent the neurological form. The vaccine isn't perfect, but it will help minimize the virus.

**IDAHO STATE TEAM SORTING FINALS**

- 1. Entry fee of \$60 per person
- 2. There will be \$500 added to the total purse by EASTERN IDAHO STATE FAIR.
- 2. Each team will consist of 3 riders.
- 3. The event will consist of 10 head of cattle; 8 will be numbered, 2 will be left blank.
- 4. An individual may compete twice at the finals.
- 5. The overall winners will be placed on both go-rounds on total number of cattle across line plus total time.
- 6. There will be two 90 second go-rounds.
- 7. There will be a fast time on each go. The winner will receive \$90 for their team.
- 8. This event will be held under EASTERN IDAHO STATE FAIR rules.

## IDAHO STATE TEAM PENNING FINALS

1. Entry fee of \$60 per person.
2. There will be \$500 added to the total purse by EASTERN IDAHO STATE FAIR.
3. There will be two 90 second go-rounds.
4. There will be a fast time on each go. The winner will receive \$90 for their team.
5. This event will be held under EASTERN IDAHO STATE FAIR rules.
6. An individual may compete twice.
7. Overall winners will be placed on both go-rounds with total number of cattle penned, plus time.

## IDAHO STATE TEAM BRANDING FINALS

1. Entry fee of \$60 per person.
2. There will be \$500 added to the total purse by EASTERN IDAHO STATE FAIR.
3. Teams consist of four riders/four head of cattle, with an 8-minute time limit.
4. An individual may compete twice at this event.
5. This event will be held under EASTERN IDAHO STATE FAIR rules.

## IDAHO STATE PRO/AM TEAM BRANDING FINALS

1. Entry fee is \$45 per person.
2. Teams must consist of four riders. Two riders must be pros and two riders must be either two women or two youth age 16 and under or one of each.
3. Women and children may enter twice; pros may enter once.
4. There will be a 5-minute time limit, 2 head of cattle.
5. This event will be held under EASTERN IDAHO STATE FAIR rules.
