PARTICIPANTS:

- 1. The EISF Shows are open to active FFA and 4-H exhibitors from the 16 counties in the fair district.
 - a. 4-H member must be currently enrolled in projects that he/she exhibits.
 - b. FFA member must be in good standing in his/her local chapter and regularly enrolled as a student of Vocational Agriculture. Students who graduated last May are eligible to compete in FFA activities and exhibits. New fall students of Vocational Agriculture are also eligible.
- 2. Record books are required on all projects and must be judged or evaluated in the respective county office. Each animal shown at EISF must be listed in the exhibitor's record book and on the exhibitor's entry form. Record books must be on the EISF premises or held by the respective County Extension Office and available for review by show chairs until the conclusion of EISF. County Extension Educator, 4-H Program Coordinator, or Ag Ed instructor will approve online entry forms only when these requirements have been met. Failure to provide record books may result in disqualification for the current year's EISF 4-H/FFA Youth events.

- 3. All 4-H and FFA members may enter open class livestock competition upon compliance with open class rules. 4-H and FFA members will not be required to pay stall fees for animals in the JR Open show but must pay open class entry fees.
- 4. All entries must be completely filled out, submitted, and paid online at: (https://fairentry.com/Public/FindYourFair select Idaho and search for "2025 Eastern Idaho State Fair 4-H") by due date for the member to qualify. Late entries will be disqualified. Pick up parking pass and tickets from your local Extension Office.
- 5. If a check-in time is listed for a contest, members must be checked in at that time.
- 6. 4-H/FFA members participating in contests will receive an entry ticket from their County Extension Office ONLY for the day on which the contest is held and/or for the days animals are required to be on site for feeding of animals. DO NOT ask at the gate for free entry. One (1) ticket will also be given for a parent to take youth to participate in show and/or feed. 4-H members exhibiting non-livestock FCS and miscellaneous projects will not receive EISF entry tickets.
- 7. Any 4-H/FFA member who fails to abide by EISF rules will forfeit premiums.
- 8. Contest participants must follow age and activity requirements for 4-H. Age Requirements: Classifications are based upon child's age January 1 of the current year. Age divisions for all contests, shows, and activities are as follows:
 - a. Junior: ages 8-10 as of Jan. 1 of current year
 - b. Intermediate: ages 11-13 as of Jan. 1 of current year
 - Senior: ages 14-18 as of Jan. 1 of current year or in 12th grade C. •
- 9. Entry Submission-All fees are non-refundable. Each youth will pay a one-time administration fee of \$3.00. Stock fee \$13.00 per class. Ultrasound fee \$7.00 per animal. Overnight Horse stalls are \$11 per stall.

AWARDS

These should be given at the time classes are judged and a record of the winners should be included in the show binder and turned into the EISF 4-H Chair Office. Show chairs, please remind youth who receive awards that they need to send a thank you note to the award sponsor.

NON-ANIMAL SHOWS

NON-LIVESTOCK FAMILY AND CONSUMER SCIENCES (FCS) AND MISCELLANEOUS PROJECTS

- 1. All blue ribbon projects from the 16 cooperating counties are eligible for display at the Eastern Idaho State Fair (EISF), including blue ribbon day camp and camp projects.
- 2. No red ribbon, white ribbon, or cloverbud projects may be displayed or receive ribbons or premiums. Counties are expected to strictly screen entries.
- 3. The 4-H member must complete all work.
- 4. An exhibit is a poster or display from a 4-H project. A record book is only needed if it is the project.
- 5. Every project displayed will receive a purple ribbon and a premium (pro-rated by the EISF board).
- 6. Any display that has been worn or shows signs of use should be cleaned before display.
- 7. County Extension staff will be responsible for the following:
 - a. Bring securely labeled, blue ribbon county projects to the fair. Exhibits must be labeled with the 4-H member's name, county, age, and project.

- b. Securely attach purple ribbons to and display all projects; attach rosettes to outstanding projects. Each county will recognize the top 10 percent of projects displayed with a rosette.
- c. Decorate modules in assigned display area with the EISF theme and promote UI Extension.
- d. Keep records of members and projects and report to UI Extension building chair.
- e. Pick up projects at the close of the fair.
- 8. Members display projects at their own risk. UI Extension, the EISF Board, and the EISF 4-H Building Committee assume no liability for theft or damage to displayed projects or record books.

4-H Demonstration Contest

Monday, September 1 at 9:00 a.m. at the 4-H Building.

Check-in: 15 minutes before assigned demonstration time: Juniors, 9-noon p.m.; Intermediates, 12:30-3:00 p.m.; Seniors, 3:15-6 p.m.

Demonstrations and presentations will be referred to as demonstrations.

All demonstrations given at EISF must be the same given at the county level with the exception that there are no longer live animal demonstrations at the EISF. You may modify a county fair live animal demonstration to not include a live animal at the state fair. For example, you can use a photo or stuffed model of your animal in place of the live animal. Demonstrations must be the original work of the member and can be used by the member for only one year. If a team is giving a demonstration and the members are not in the same age division, they must compete in the higher age division. If a member has scheduling problems due to other 4-H events, he or she must contact the show chair to make special arrangements. No other persons will be allowed on the stage <u>during</u> the demonstration.

A table, easel, laptop and microphone will be provided for demonstrations. You will need to download all electronic presentations onto a jump drive compatible with a PC (no Mac's). The internet is not reliable in the 4-H building. Please contact the show chairs: Kari Ure, Bear Lake County 208-847-0345 or Leslee Blanch, Bonneville County 208-529-1390, by August 27th if additional equipment is needed.

Scheduling of Demonstrations:

A demonstration time will be assigned, and notifications will be sent to the member's Extension Office and member's family email address. A demonstrator not ready at the assigned time may be disqualified. If an earlier time is desired, check in with the show chair to see if an earlier time is available.

Number of Demonstrations Counties Can Send:

Each county can send their top blue-ribbon demonstrators in the following categories:

- Junior Division (ages 8-10 as of Jan. 1 of current year): 5 demonstrations
- Intermediate Division (ages 11-13 as of Jan. 1 of current year): 5 demonstrations
- Senior Division (ages 14-18 or in 12th grade as of Jan. 1 of current year): 5 demonstrations

Length of Demonstrations:

The length of time listed below represents the minimum and maximum that a demonstration can be. Question and answer time is not included in demonstration time.

- Juniors: 5 to 8 minutes
- Intermediate: 7 to 10 minutes
- Seniors: 9 to 12 minutes

Scoring:

- Planning (35 points) organization and information
 - Opening (5) interesting, title grabs attention, introduces subject
 - \circ Body (10) main thoughts in logical order with supportive information
 - Accuracy (5) current, factual
 - Practical (5) information useful
 - Summary (5) brief review of main points
 - Visuals (5) illustrate main ideas, neat, large enough to be seen
- Delivery (65 points) manner used in presenting information
 - Posture (10) carries body well and avoids shifting
 - Dress (5) neat, well-groomed
 - Friendliness (10) smiles, presents a positive image, eye contact
 - Confident Manner (10) comfortably discuss material without reading everything
 - Ease of demonstration (10) handles visuals smoothly and orderly
 - Speaks Distinctly (10) loud enough to be heard, clear enough to be understood
 - Pronunciations (10) states words correctly
- Points will be subtracted for over or under time up to 5 points

Style Revue Contest

Models will be divided into three divisions: Junior, Intermediate, and Senior. Each participant can model only one outfit. Any model receiving a blue ribbon at their county fair is eligible. Any sewn item that is wearable can qualify.

Scoring:

- Poise or Stage Presence (3 points) walks smoothly at an appropriate pace, hand movements appropriate
- Eye contact (3 points) looks upward and forward not watching their feet
- Confidence (3 points) comfortable on stage
- Garment Appearance (3 points) garment should fit well and be age appropriate
- Attitude (3 points) proud of accomplishments, shows enthusiasm
- Grooming (3 points) model & clothes should be neat, clean & pressed

4-H/FFA Youth Dog Show

This rule book offers a partial listing of Dog show rules. For a complete set of rules, please contact your County office or Madison County (208-356-3191) to receive a copy of the 2025 Eastern Idaho State Fair 4-H Dog Show Rules Supplement. It is your responsibility to read, understand, and follow all rules in the supplement.

Please remember dogs are not allowed on the Fairgrounds before or after the Dog Show. They must be kept on a leash before and after his/her performance. Please do not let your dog roam freely. Crates are highly recommended. This is NOT an AKC-sanctioned dog show.

Dog Show Rules

- 1. Youth may enter any discipline, level, and class they are eligible for as outlined in the 2025 Eastern Idaho State Fair Junior 4-H Dog Show Rules. The handler and dog must be able to perform the exercises required of the disciplines/levels/class(s) entered. Youth may not enter classes without both youth and dogs being prepared prior to the State Fair to perform the required exercises. A zero (0) will be given to any handler/dog team not attempting an exercise, except as provided otherwise specifically in the rules. A zero (0) on the exhibitor's score sheet will result in an incomplete for that class. Therefore, the exhibitor will not be eligible for an award, except as provided otherwise specifically in the rules. Exhibitors may show one or more project dogs, provided the exhibitors and dogs meet the eligibility requirements of each respective class.
- 2. Project eligibility and class or classes entered must be determined at the county level, based on the experience and ability of the handler/dog team. 4-H member must show dog in the same class that he/she received a blue ribbon at the county fair. The Extension office must certify this. Extension offices must verify the youth is a member in good standing in their county to be able to participate at the Eastern Idaho State Fair.
- 3. Only domestic dogs can be shown. Wolf and wolf hybrids are not permitted.
- 4. All dogs exhibited must be **six months of age** by the date of the show. Proof of age is the burden of the exhibitor or exhibitor's immediate family. Dogs not meeting this age requirement cannot be shown.
- 5. Dogs shown at the Eastern Idaho State Fair Dog Show must be the same project dogs taken by 4-H members at the county level.
- 6. Sharing a dog at the county level is not permitted for State Fair Dog Show participation. If two youth share a dog at the county level, neither youth is eligible to show that dog at the State Fair. (Exception—sharing with a cloverbud exhibitor at the county level).
- 7. The judge will not permit an exhibitor to train or practice any exercise in the show ring at any time.
- 8. No one other than the junior fair exhibitor is permitted to show the project dog(s) at any type of dog show, including agility, field trials, rally trials, etc., as well as fun matches, *during the 90- day project period*.
- Any dog exhibiting unsafe or threatening behavior at any time before, during, or after exhibition MUST be removed from the fairgrounds and will not be permitted to return at any time throughout the Dog Show. Determination of the show committee and/or judge will be final.
- 10. The judge or show officials *will immediately* excuse from the ring any dog exhibiting unsafe, threatening or other disturbing behavior.
 - a. The judge will *immediately* excuse any dog that appears dangerous to other dogs or exhibitors.
 - b. Any dog that snaps, bites, or attempts to bite any person or dog while in the show ring will *immediately* be excused and disqualified from the class and any awards.

- c. If a judge determines that a bitch in the ring is in season or appears to be so attractive to males as to be a disturbing element, the bitch is *immediately* excused. The judge shall not obtain the opinion of the EISF officials.
- d. Bitches in season may compete upon the conclusion of regular judging for premium ribbons only. Placement in class will not be given. Bitches in season and bitches who have recently whelped and have discharge must be kept outside of the arena area until called.
- 11. Any uncontrolled behavior such as barking, running away from its handler, etc., will be penalized according to the seriousness of the misbehavior, whether it occurs during or between exercises, or before or after judging.
- 12. Any dog not under its handler's control may be excused from the competition.
- 13. Any exhibitor or other person(s) abusing a dog will be removed from the fairgrounds.
- 14. The judge or show officials will dismiss from the ring any exhibitor abusing a dog, which *will* result in disqualification of exhibitor *and* removal from the Fairgrounds.
- 15. Judges and/or show officials have the right to deduct points from the Sportsmanship category on the exhibitor's score sheet if unsportsmanlike conduct is displayed at any time throughout the 4-H dog show prior to or during judging.
- 16. Judges and/or show officials have the right to disqualify any participant exhibiting poor sportsmanship at any time throughout the 4-H Dog Show from showing, participating in activities, or receiving any awards.
- 17. Any handler who willfully interferes with another competitor or that competitor's dog will be excused from the competition.
- 18. Exhibitors, parents, volunteers, and other individuals verbally and/or physically abusive or threatening to show personnel will be removed from the Fairgrounds, and exhibitors will be disqualified.
- 19. Show officials have the right to order the removal from the Fairgrounds to anyone showing unsportsmanlike conduct.
- 20. Individuals who violate any rule and/or exhibit poor sportsmanship during the EISF 4-H Dog Show will be disqualified from showing.
- 21. Individuals with concerns must express them in writing, give them to Show Personnel, and those concerns will be discussed after the EISF dog show with dog show personnel. Confrontations with judges and/or show personnel may result in disqualification of exhibitor and removal of individuals from the Fairgrounds.
- 22. Exhibitors must check-in at their show ring within 15 minutes after being called to their ring.
- 23. Exhibitors who do not check-in at their show ring within 15 minutes after being called will have sportsmanship points deducted on their score sheets.
- 24. An exhibitor disciplining a dog in the show ring will be excused from further competition in that class.
- 25. Physical or verbal discipline of a dog is not permitted except in case of an attack on a person or another dog.
- 26. The judge will not permit any handler to use excessive verbal commands or to move toward the dog to correct it.

- 27. Exhibitors are totally responsible for their dogs while on the Fairgrounds.
 - a. Dogs must be kept on leash while on the Fairgrounds, except when participating in the ring during judging.
 - b. Exhibitors must clean up after their dogs.
 - c. Dogs must not be left unattended.
- 28. A dog that snaps, bites, or attempts to bite must be immediately excused from the ring. Dogs excused from the ring will be disqualified from the class and any awards.
- 29. Exhibitors will be disqualified if their dogs are seen wearing muzzles, prong/pinch collars, or electronic collars.
- 30. Only the exhibitor's dog, exhibitor, and show officials are permitted in the show ring area at any time throughout the show.
- 31. Judges' decisions are final. Exhibitors, parents, volunteers, and other individuals are not permitted to talk with judges at any time during the Dog Show, except during class briefings and walkthroughs.
 - a. Discussion and/or confrontation with judges may result in disqualification of exhibitor and removal of individuals from the Fairgrounds.
- 32. ALL dogs must have current Rabies vaccinations, administered by licensed veterinarians. Veterinarians must document on the 2025 EISF Vaccination Certificate, whether the exhibitor's dog's rabies vaccination is current by filling in the "date expires" blank.
- 33. ALL dogs must be vaccinated for Distemper, Adenovirus, Bordetella, *and Parvovirus* by licensed veterinarians. If the veterinarian does not administer certain vaccinations, those vaccinations must be noted by the administering veterinarian, either on the vaccination form or letterhead.
- 34. Any dogs exhibiting abnormalities or symptoms of sickness, disease, or parasite infestation as determined by the EISF officials will be eliminated from the show and must be removed from the Fairgrounds. If a dog is under veterinary care for a health condition that is not infectious or contagious, the exhibitor must bring a health certificate from the attending veterinarian verifying the condition and treatment. **The decision of the EISF officials is final.**

Horse Show Rules

- 1. The EISF Junior Horse Show is an **optional activity** for top, blue ribbon exhibitors. Project animals may be registered or unregistered equines of any breed.
- This rule book offers a partial listing of Horse show rules. For a complete set of rules, please contact your County office or Jefferson County (208-745-6685) to receive a copy of the 2025 Eastern District 4-H Horse Rules Book. It is your responsibility to read, understand, and follow all rules in the supplement.
- 4. No member or horse/pony may show unless they are enrolled in a **bonafide 4-H horse project, FFA chapter, or Pony Club** in their respective county and fulfill the completed county requirements for each division, excluding showmanship. The horse/pony shown at the EISF Junior Horse Show must be the same horse/pony that qualified in that particular class at the respective county show, all certified by the County Extension Educator.

- 5. Due to the risk of spreading equine related diseases it is highly recommended that all temperature of horses is taken daily 3 days prior to entering the fair grounds. If a horse has an elevated temperature of 101.5 degrees or greater, a veterinary should be consulted before coming to EISF.
- 6. No overnight parking will be allowed in the infield any night prior to EISF 4-H/FFA Horse Show events. Those wishing to camp may do so at no cost in the EISF Northwest gravel pit and field area. Utilities will not be available. This policy is due to stringent security requirements for main arena events. Horses may be hauled into the infield beginning at 6:00 am prior to both hors shows Friday and Saturday. Trucks and Trailers must be removed from EISF infield no later than 4:00 pm on Friday and Saturday to accommodate the evening fair events.
- 7. **Stalls** are available on a first come, first serve basis for those that live further than 1 hour from the EISF grounds. Those living within an hour (Bingham, Bonneville, Jefferson counties) will be put on a wait list and placed if available. To reserve a stall, call Amanda at Jefferson County, 208-745-6685.
- 8. **Release of liability:** The EISF Junior Horse Show Committee, the EISF Board and the University of Idaho will not be responsible for any accident that may occur to, be caused by any horse or exhibitor at the show, or for any article of any kind that may be lost, destroyed or in any way damaged. Exhibitors and observers participate at their own risk. Collection of exhibitor number shall be deemed acceptance of these terms.
- 9. No horse/pony may be shown by more than one exhibitor in any one class.
- 10. No exhibitor may show more than **one horse/pony** in any one class (except team events in Driving Division).
- 11. In the event of a serious, performance inhibiting injury to a qualifying, enrolled project horse, the exhibitor *may*, at the discretion of the EISF Junior Horse Show Committee, be entitled to a medical exclusion and may use a different enrolled project horse, owned by the immediate family. The individual must notify the EISF Junior Horse Show Committee in writing and submit a letter written by a licensed veterinarian stating that the horse/pony was indeed injured and unable to perform on the day of the show.
- 13. Good sportsmanship and ethical behavior are required. Exhibitors, parents and observers will act as ladies and gentlemen at all times. Exhibitors, parents and observers considered to be verbally or physically abusive and/or exhibiting objectionable behavior will be excused from the fairgrounds by security at the discretion of the EISF Junior Horse Show Committee. Exhibitors may also be disqualified.
- 14. Exhibitors must secure their horses at all times, no grazing allowed on the fairgrounds.
- 15. Use of performance altering drugs on horse/pony is prohibited. Suspicion of drug use may result in a veterinarian's review and/or blood test, the cost of which may be deducted from any premium allocated to the exhibitor in question. The exhibitor may be barred from the present and the next year EISF Junior Horse Show.
- 16. Grievances. Any issue/grievance that cannot be resolved by the show chair shall be presented to the EISF Junior Horse Show Committee in writing within 2 hours of the issue/grievance. In the event a grievance is not covered by the EISF Junior Horse Show Rule Book, the committee may refer to the U.S. Equestrian Federation Rules as a secondary reference. A \$25 fee must accompany the written issue/grievance. The \$25 fee will be returned if the grievance is overturned. The decision of the EISF

Junior Horse Show Committee is final.

- 17. Direct criticism, confrontation, threatening behavior, or any other type of interference with the EISF Horse Show Committee, officers and/or members, the judge, show management, other exhibitors, breed representatives or show officials before, during or after the competitive event is prohibited. Any violations of this rule will result in immediate dismissal from EISF 4-H Horse events for the current year. Physical violence will result in a permanent ban from EISF 4-H Horse events.
- 18. Only the entered rider(s) of a horse/pony(s) may ride the horse/pony(s) on the day of competition.
- 19. Showmanship classes are limited to one entry per age division from each qualifying county show.
- 20. Western, English, Driving and Working Ranch Horse classes allow two (2) entries from each qualifying county horse show with the exception of Team Sorting. In addition, one (1) entry may be sent for each ten (10) contestants participating in that class at the qualifying county horse show. The Western Reining and Horsemanship classes allow one entry per every 10 contestants
- 21. Each exhibitor may enter a maximum of one (1) Showmanship class, two (2) Western classes (bareback, equitation, reining, horsemanship or reining, trail), two (2) Driving classes, two (2) English classes, one (1) Snaffle Bit class, two (2) Working Ranch Horse classes, and Team Sorting (one team).

- 22. Exhibitors qualifying for both **Western Reining and Western Horsemanship** may enter only one.
- 22. . Numbers and programs must be picked up on the infield below the announcer's stand, not at the EISF Livestock Office. Assigned numbers must be clearly visible on the competitors back or both sides of saddle blanket at all times during the competition.
- **23.** Patterns will be included in the packet for each exhibitor the day of the show.
- 24. The EISF Junior Horse Show Committee reserves the **right to make sections in any class**, divided by age of exhibitor, sex or size of horse/pony, etc. Multiple rings will be used as needed. Select classes may be run on the track or infield.
- 25. Exhibitors are responsible for proper equipment and attire according to the guidelines outlined in this publication. The EISF Junior Horse Show Committee, judge, Extension Educator, gate official and/or ring steward has the authority to dismiss an exhibitor from a class. The judge may ask the exhibitor to drop the bridle and bit for inspection.
- 26. 4-H and FFA members participating in any 4-H equestrian activity **must** wear an approved helmet whenever they are mounted on an equine or are in a vehicle (cart, wagon, buggy, etc.) being pulled by an equine. An approved helmet meets the minimum performance standards imposed by the American Society for Testing Materials (ASTM) F1163 and includes certification and labeling required by the Safety Equipment Institute (SEI). The helmet must be properly fitted with the harness engaged and

properly fastened. It is recommended that 4-H'ers ware their ASTM/SEI helmets any time they are around their horse.

- 27. Be ready and on call for each class. Classes may not fall in numeric order.
- 28. Classes will not be held for **tardy exhibitors**. After the gateman announces, "Judge, this is your class," no horse/pony or rider may enter the ring and be judged.
- 29. Rail classes will begin working counter clockwise.
- 30. **Reversal of direction** in any class requiring rail work, indicates horse/pony be reversed to the inside of the arena (away from the rail).
- 31. The judge may request **individual workouts** from the top 6-10 finalists per class.
- 32. All horse/pony shown in Western classes, with the exception of Snaffle Bit/Hackamore Training, must be shown as a bridle horse/pony with a **standard western bit** as described in the Appendix.
- 33. Horse/pony entered in **Snaffle Bit/Hackamore Training** may not be shown in any other Western, English, or Driving class.
- 34. Exhibitors entered in the Western/English **Walk-Trot** class may not enter any other Western, English, or Driving classes.
- 35. Small and medium ponies (<u>13</u> hands and under) must show as ponies, if a class is offered; large ponies (<u>13–14</u> hands) may show as either horses or ponies, but not both.
- 36. <u>Horse/pony 13 hands and under will not compete in working ranch classes that cattle will be</u> <u>worked.</u>
- 37. Only **stallions** born after January 1 of the current year may be shown in the EISF Junior Horse Show.
- **38.** Disqualifications: The EISF Junior Horse Show Committee, judge, Extension Educator, gate official and/or ring steward has the authority to dismiss an exhibitor from a class or from the show for: unnecessary roughness; abuse of horse/pony; unsound horse/pony; unsafe horse/pony; fall of horse/pony or rider; lack of required appointments; use of prohibited appointments (Working Ranch Horse classes have no appointment restrictions); use of performance altering drugs on horse/pony; failure to follow pattern and/or judge's instructions (only the judge may disqualify for this fault); tack disqualifications (need wording for referral to appendix)
- 39. Awards are based on the merit of the exhibit. The judge may disqualify an exhibit or award the exhibit any ribbon at his/her discretion.
- 40. **Rosette ribbons** will be awarded to the top six individuals in each class. Premiums are paid on first to sixth place in all classes.
- 41. This is the list of classes for the Eastern Idaho State Fair Junior Horse Show. Actual class order will be posted the day of the show. Show ring will be split the day of the show to facilitate the number of classes and participants.

Poultry Rules:

- 1. Each 4-H/FFA participant is restricted to entering a maximum of two birds total in the entire poultry show. Exhibitors must be present during judging, or the poultry will not be judged. 4-H/FFA participants must be well groomed and in appropriate show attire.
- 2. Exhibitors must check in with show management and receive exhibitor numbers before the show. Exhibitor numbers will be available one hour before show time. No exhibitor numbers will be issued after the judging has begun.
- 3. Poultry should arrive immediately before the show and will be released immediately following. All birds must be kept under control or in an enclosed cage during the entire show.
- 4. All poultry must qualify for quality classes by receiving a blue ribbon at their county fair in a QUALITY CLASS, similar to state fair classes listed below. Each 4-H/FFA participant is restricted to showing only one bird per category.
 - a. Participants whose poultry qualify for a quality class may choose to participate in showmanship, regardless of their showmanship ribbon at the county fair. Participants who received a blue ribbon in showmanship at the county, but did not qualify for a quality class, may exhibit in showmanship only.
- 5. All animals must be the property of the exhibitor. Only exhibitors, or their agents and authorized show personnel will handle poultry.
- 6. All poultry must be shown in natural condition. Grooming that does not alter original state of the animal is permitted.
- 7. All poultry must be health checked at check in. HEALTH RULES:
 - a. Any bird showing signs of illness will be removed from the show. No bird may be entered that has leg mites, lice, parasites, C.R.D., or any other health problem.
 - b. No poultry will be admitted that have been recently vaccinated for any diseases.
 - c. Poultry to be entered are not allowed to have a "hen pecked" appearance, signs of molting, injury, cock fighting, or any signs of abuse and neglect.
- 8. QUALITY CLASSES: Poultry will be judged on the criteria stated by the APA handbook, "American Standard of Perfection." The birds will be judged based on traits and characteristics of their particular breed, as well as the presentation. All poultry to be entered into a particular class must meet the class's specific guidelines. Poultry in quality classes are allowed to compete in only one category.

Individual Poultry animals can compete in both the quality and showmanship classes but are not required to show in both.

- 9. All decisions, recommendations, and comments made by the show chairman and judge are final and cannot be disputed. Unacceptable or disruptive behavior by spectators and participants can result in being removed and disqualified from the show.
- 10. Show management reserves the right to subdivide any or all classes at their convenience.
- 11. The EISF, show management, coordinators, Extension Educators, or staff are not responsible nor can they be held liable for any damage, accident, illness, or death of any person or animal, or damage to property.

4-H/FFA Youth Livestock Shows

By participating in the Eastern Idaho State Fair (EISF) 4-H/FFA shows you agree to abide by and follow the rules listed below. Any violation results in immediate dismissal from EISF 4-H/FFA Youth Livestock events for the current year. Exhibitors will forfeit any premium, award, and/or auction proceeds and will be prohibited from further participation at EISF 4-H/FFA Livestock events.

General Rules:

1. The EISF 4-H/FFA Youth Livestock Committee makes the final decision on all rule violations, grievances, and other issues.

- 2. How to file a Grievance: Any issue/grievance needs to go to the species chair in writing with a \$25 fee. The species show chair will collect data. If they cannot resolve the issue, they will take the item to the Executive Committee. The EISF 4-H/FFA Youth Livestock Sale Executive Committee will have 2 hours from receipt of written issue from show chair to act on the issue. The \$25 fee will be returned if the grievance is overturned. The decision of the EISF 4-H/FFA Youth Livestock Sale Executive Sale Executive Committee is final. The terms of the grievance shall be cash and/or bankable check.
 - a. At any given time, the Executive Committee (unless extenuating circumstances arise) will consist of at least five members, who may include the president, vice president, secretary, at least one species Chair and the Extension 4-H staff member that reports to the EISF board to make final decisions.
- 3. <u>Direct criticism, confrontation, threatening behavior, or any other type of interference with the EISF 4-H/FFA Youth Livestock Committee, officers and/or members, the judge, show management, other exhibitors, breed representatives or show officials before, during, or after the competitive event is prohibited.</u> Physical violence will result in a permanent ban from EISF 4-H/FFA Youth Livestock events.
- 4. Illegal, off-label, and/or extra-label drug use is prohibited. Any violation results in immediate dismissal from EISF grounds.
- 5. Drenching is allowed under the direct supervision of an EISF veterinarian, an EISF 4-H/FFA Youth Livestock species chair, or an identified committee member. The vet, species chair, or committee member must be present when the animal is being drenched.
- 6. All exhibitors will advise show management <u>in writing</u> of any drug and/or medication administered to an animal using the EISF Market Animal Medication Record sheet. Failure to report this information accurately will result in severe penalties and/or disqualification. Any use of drugs or substances not approved and labeled by the FDA is strictly prohibited.
- 7. All medications administered to animals enrolled in a market class must meet their labeled withdrawal date by the date and time of the market animal sale.
- 8. The use of feed products with Ractopamine (i.e.Paylean), is banned in all animals with the exception of labeled use in swine.
- 9. All animals entered in livestock competition will be subject to testing for foreign substances that exceed acceptable levels established by the FDA, FSIS, USDA, and/or EPA.
- 10. During the livestock event, in the case of an animal requiring treatment, all medication shall be administered by a licensed veterinarian and the EISF 4-H/FFA Youth Livestock Committee must be notified.
- 11. Surgery, injection, or insertion of foreign material under the skin and/or into the flesh of an animal to change the natural contour, conformation, or appearance of the animal's body is illegal. Acceptable practices of physical preparations are allowed include: clipping of hair, trimming of hooves, dehorning, or removal of ancillary teats. All Grand and Reserve Grand Champion animals will be subject to a hands-on veterinarian inspection.
- 12. Muzzles are not allowed on animals.
- 13. Animals that have been shown in a market class at a county fair may not be shown in an EISF 4-H/FFA Youth Show Breeding Class and vice versa.
- 14. All livestock must meet the following health requirements:
 - a. All animals must be free of any evidence of clinical disease.
 - b. All animals entered are subject to inspection at the fairgrounds by the EISF 4-H/FFA Youth Livestock Committee, Department Superintendent, and/or the EISF Veterinarian <u>during that</u> <u>species weigh-in/check-in.</u>
 - c. Any animal that has evidence of disease, including but not limited to, coughing, excessive oral or nasal discharge, open sores, lameness, hernia, diarrhea or external parasites, may be

isolated for further examination or entry may be refused. In all cases the decision of the EISF 4-H/FFA Youth Livestock Committee, Department Superintendent, and/or EISF Veterinarian will prevail.

- d. Animals that develop clinical evidence of disease after entering the fairgrounds may not be shown and shall be subject to quarantine or expulsion, depending on the seriousness of the disease symptoms.
- e. The Department Superintendent, EISF Veterinarian, and/or EISF 4-H/FFA Youth Livestock Committee will make the final decision regarding animal health violations.
- f. Any animal disqualified for health reasons must be removed from the fairgrounds immediately.
- 15. Exhibitors will be required to show proof of ownership (Brand inspection or recorded iron brand for market beef, bill of sale, lease agreement, and/or COOL documents all of which will be turned in with their registration online). Market lambs and meat goats for at least 60 days; 90 days for breeding sheep and goats; 100 days for market hogs; 120 days for dairy heifers and 150 days for market beef and breeding beef. The length of time will be measured from the date of the EISF final weigh-in. Every animal entering the sale must be owned by either a 4-H or an FFA member and weighed for EISF at the official EISF weigh-in.
- 16. All 4-H or FFA exhibitors can show only one animal in Showmanship. Youth are REQUIRED to show their own breeding project or their own market project animal that meets weight requirements in Showmanship. Youth that do not have a breeding project or an animal that meets weight requirements may show their light-weight animal in showmanship, but not quality. All animals shown must be a 4-H/FFA breeding or market project and be owned by the exhibitor.
 - a. SHOWMANSHIP CLASS ORDER (classes may be combined)
 - i. Senior Division (age 14-18 as of Jan. 1 of current year)
 - ii. Intermediate Division (age 11-13 as of Jan. 1 of current year)
 - iii. Junior Division (age 8-10 as of Jan. 1 of current year)
- 17. All 4-H/FFA exhibitors may exhibit either a market or breeding animal in showmanship as long as that animal is in the exhibitor's record book and entered in the correct EISF 4-H/FFA livestock quality show class, with the exception of sheep and rabbit. A breeding sheep showmanship class and breeding rabbit showmanship class is already available.
- 18. Quality will be run by classes, with FFA and 4-H exhibitors showing together in the 4-H/FFA Youth Show by class list.
- 19. DRESS CODE: Exhibitors must wear a shirt with a collar and long pants in order to show and sell. No sweats or open-toed shoes are allowed. FFA exhibitors must be in official FFA attire to show and sell. Rabbit Show youth must wear a white, button-down shirt with a collar and long sleeves. Dairy Goat youth must wear a white shirt with a collar and long white or black pants. Youth will not be allowed in the show or sale ring until properly dressed. If a youth with multiple animals, each animal must have its own appropriately dresses 4-H/FFA handler. Accommodation for extenuating circumstances can be approved by show chair prior to start of EISF. Accommodation must be in writing.
- 20. All livestock exhibits will be judged on the "American System" with ribbons for 1st through 6th place. All awards will be given at the discretion of the judge(s).
 - a. No exhibitor will be paid more than two premiums in any one class.
- 21. All breeding and dairy animal projects must meet their county's requirements to participate in EISF 4-H/FFA Youth Livestock Shows.
- 22. Adults cannot show an animal owned by a 4-H/FFA Youth exhibitor in a 4-H/FFA Youth show. Only 4-H/FFA Youth exhibitors may show in the 4-H/FFA Youth shows.

- 23. The selected first and second of each class will compete for Grand Champion and Reserve Grand Champion.
- 24. All animals must be entered and released according to schedule. Any 4-H/FFA Youth exhibitors show animal that does not go on the resale truck or to the packer must stay until 2 p.m. on the final Saturday of the fair. Resell and Packer animals must stay until Noon on the final Saturday of the fair. Anyone who leaves early will be fined \$250 to be payable either this year or next year at registration.
- 25. Each exhibitor shall arrange for animal care and furnish the feed, bedding, watering, and cleaning equipment for his/her animal(s). Sheep, goats, and dairy cattle must use shavings or straw. All other livestock must only use shavings. One bag of shavings per person will be provided; additional bags may be purchased on the EISF grounds.
- 26. Each exhibitor is responsible for the daily care and cleanliness of his/her pen or stall through 2:00 p.m. on the final Saturday of the fair or until the animal has been removed from the fairgrounds; whichever occurs first.
- 27. **Stalls must be cleaned by 8 a.m. each day.** A \$90 charge for beef and \$50 for all other animals will be charged to the exhibitor(s) for pens or stalls not kept clean following one verbal warning by the EISF 4-H/FFA Youth Livestock Committee, the show chair, and/or superintendent.
- 28. Animals must be treated humanely. Any egregious acts such as animal abuse, rule infractions and other noncompliance of any rules by the exhibitor, parent and/or guardian will not be tolerated.
- 29. The EISF and/or the EISF 4-H/FFA Youth Livestock Committee reserve the right to refuse admittance or remove from the fairgrounds all unmanageable animals that may endanger public safety or damage property that may arise while livestock are on exhibition or involved in the sale.
- 30. Neither EISF, the EISF 4-H/FFA Youth Livestock Committee, fair district, or the sale officials shall be held responsible for any damage or loss that may arise to livestock on exhibition or sale.

Sale Rules:

- 1. A youth may tag three (3) animals of each species for EISF. Exhibitors may register and show two (2) of those tagged animals in each species.
- 2. Animals that have been shown in a county fair market animal class intended to qualify for a county fair sale CANNOT be exhibited in the 4-H/FFA Youth show at EISF. The Extension Educator, 4-H Program Coordinator, or Ag-Ed instructor from each county or chapter will be responsible for verification of ownership and project enrollment.
- 3. Tagging and DNA tissue sampling rule-Please see the EISF 4-H Parent/Guardian & Exhibitor factsheet for a detailed tagging and tissue sampling protocol. Please contact your county if you have not received one. It is available in the EISF Supplement provided to them.
 - a. All animals designated for EISF 4-H/FFA Youth Livestock Events must be tagged and tissue sampled <u>in accordance with the DNA/Tagging Protocol</u> by a representative from their respective County Office at an approved county weigh-in.
 - b. All animals will be tagged with a tamper-proof tag provided by the EISF Market Animal Sale Committee.
 - c. In each market animal show, once the Grand Champion and Reserve Grand Champion animals have been chosen a second tissue sample will be collected from those animals. Exhibitors of animals found without matching DNA will be immediately disqualified from all EISF 4-H/FFA Youth livestock shows and permanently banned from future participation at EISF.
 - d. If an EISF designated animal loses its EISF tag a second DNA sample will be collected when it is retagged.

- e. Youth exhibitors will pay for the tags and tissue sampling kits, including when tags are lost. The youth will be required to pay for additional tags. The youth will also be required to pay for half the DNA comparison test if animal is a Grand or Reserve Grand Champion to confirm animal is the same as originally tagged.
- 4. Weigh in Rules:
 - a. All animals weigh one time only. Minimum qualifying weights for each species are listed below:
 - i. Market Beef 1,100 pounds
 - ii. Market Lamb 110 pounds
 - iii. Market Swine 230 pounds
 - iv. Market Goat 70 pounds
 - v. Market Rabbit over 4 pounds per animal (small breeds, i.e. Florida Whites, Havana, etc. will be accepted at 2 ½ pounds).
 - b. Any animals that arrive <u>without proper tags/tattoos or wrong tag/tattoo information in their</u> <u>paperwork</u> and all lightweight animals will be disqualified from market <u>quality</u> classes.
 - c. Halters and collars must be removed from sheep and goats prior to entering scale for weighin.
 - d. <u>Animals that arrive after the designated weigh-in time for that species will not be weighed or exhibited.</u>
 - e. Species chairs and/or co-chairs will be responsible for assigning pens to an individual/family for their animals. Tack stalls/preparation areas may or may not be provided to an individual/family and will only be provided at the species chairs' discretion if availability exists. If multiple species share the same area, the chairs of those species will work together to prepare these pen assignments.
- 5. Drug Screening Rule:
 - a. The Grand and Reserve Grand Champion of each market species will be screened for illegal drug use immediately following the show before the animals can return to the stall/pen area.
 - b. Sample collection for the drug test will be conducted by an accredited veterinarian or veterinarian technician and overseen by an Extension Educator and species chair to protect the integrity of the 4-H program.
 - c. The EISF 4-H/FFA Youth Drug Screening Chair will coordinate the collection, submission, and testing of the samples and follow collection guidelines based on the recommendations of the testing lab.
 - d. Payment of testing will come from animal commissions and EISF (50/50).
 - e. Payment responsibility in the case of a split sample test will be the responsibility of the exhibitor and must be requested at the time of sampling.
 - f. Results will be returned to the EISF 4-H/FFA Youth Drug Screening Chair.
 - g. In the event a positive sample is found, a recall will be issued on the harvested animal. Buyer money will be refunded. The 4-H/FFA participant will be responsible for any costs incurred and will be permanently banned from all EISF 4-H/FFA Youth Market Livestock events. The participant will also be subject to any and all relevant criminal prosecution. Please see EISF Supplement provided by your county Extension office for the drug testing protocol.
- 6. Sale Order Rules:
 - a. All market livestock will be sold without a shrink. All market animals entering the auction ring must be sold.
 - b. Livestock will be placed in sale order by the judge of each species. Class winners are not guaranteed a slot in the sale order. After the selection of the Grand and Reserve Grand

Champion animal, any remaining exhibitor that does not wish to sell their animal must immediately exit the show ring with that animal with the exception Market Rabbit Show. After the placing of the Grand Champion Market Rabbit Pen, the judge will pause to allow the Grand Champion to pull out any additional pens. Once an exhibitor has an animal placed in sale order any other entries from the same exhibitor will no longer be eligible for sale order and must be removed from the show in that species.

- c. Exhibitors will be allowed to sell one animal.
 - i. Unless that exhibitor wins Grand Champion AND/OR Reserve Grand Champion in the same species or more than one species (example: An exhibitor wins Champion market lamb and Reserve Champion market lamb they must sell both. An exhibitor wins Reserve Champion market swine and Champion market beef they must sell both.)
 - ii. All Grand Champion and Reserve Grand Champion animals must be sold.
- b. Only the top 20 animals per market beef, sheep, meat goat, and swine may sell. Only the top 5 market rabbit pens may sell.
- c. In the event the top placing ultrasound carcass beef, sheep or swine didn't qualify for the sale as determined by the judge, they will be added to the sale order. They will be listed as the top carcass animal in that species <u>and sold following all of the grand and reserve</u> <u>champion animals.</u>
- d. A 3% commission or \$25, whichever is greater, for each animal sold at the EISF livestock sale will be deducted from each exhibitor's sale check. A thank you list will be given to your county office by Monday, September 15. Thank you's must be shown to your county office so that you can be checked off as completed. Checks will be mailed to your county office to be picked up following completion of thank you list being checked off and your buyer has paid. A monthly \$25.00 fee will be charged if thank you has not been completed by January 1, 2025.
- e. Once an animal has gone through the auction, regardless of buy-back or no-sale, ownership has changed.
- f. The sale committee species chair will take bids from potential floor buyers to determine the floor prices.
- g. If showing multiple species, a designation of which species will be sold needs to be relayed to the sale treasurer within 30 minutes of the conclusion of the Market Meat Goat Show or if beef is one of the species within 10 minutes of the completion of the Beef Show.

Species Specific Rules

Beef and Dairy Cattle

- a. All female cattle over six months of age exhibited at EISF shall have an official, legible Brucellosis tattoo and an official orange Brucellosis tag or silver USDA tag.
- b. All sexually intact cattle over 18 months of age that have been in the Brucellosis Designate Surveillance Area (DSA) between January 1 – June 15 shall have an official negative agglutination blood test for Brucellosis within 30 days of fair entry. Blood samples, tests, and reports must only be done by personnel authorized by the Idaho State Department of Agriculture.
- c. All dairy cattle must have a veterinary certificate of general soundness and good health. All female cattle four months of age or older should have a legible Brucellosis vaccination tattoo. Tattoos should be verified by a licensed veterinarian on an official health certificate. All cattle must meet the Idaho change-of-ownership requirements.

- d. Beef showing evidence of stagginess will be disqualified at the discretion of the EISF 4-H/FFA Youth Livestock Committee and/or judge.
- e. Market beef must be dehorned.
- f. All cattle must be tied with substantial halters and neck ropes.

Sheep

- a. All sheep must be inspected for any indications or symptoms or signs of Blue Tongue, contagious Ecthyma/sore mouth, foot rot, sore sheath, ringworm, club lamb fungus, including unhealed lesions, or any other infectious disease.
- b. If a lamb prolapses while in the show ring it will be immediately dismissed and disqualified. The prolapsed animal will be required to be removed from the grounds immediately.
 - i. Prolapse is defined as a portion of the rectum permanently protruding outside of the anus. If a lamb prolapses at any other point in time, while on the grounds, the youth will be responsible to work with a veterinarian to remedy the prolapse.
- c. All breeding sheep must be properly groomed, washed and clipped according to breed requirements. Breeding sheep must be slick sheared or carded. White face breeding sheep do not have to be washed.
- d. Sheep and goats must follow National Scrapies laws. Sheep Scrapie tags must be properly attached to the ear according to federal regulations. Failure to do so will result in dismissal from EISF.
- e. Wethers showing evidence of stagginess shall be disqualified.
- f. Market lambs must be slick shorn within 5 days of EISF weigh-in.
- g. Ram lambs <u>will</u> be disqualified from the market animal show.
- h. Lambs showing yearling teeth will be disqualified.

Swine

- a. Any swine with evidence of pigginess, stagginess, scars, hernia, foul sheath, sores, bruises, and/or any other blemish that impairs the carcass, such as lice, mange, erysipelas, atrophic rhinitis, or any other infectious disease will be ineligible to show or sell.
- b. Market hogs may be barrows or gilts only.
- c. Any clipping of swine must be done prior to arriving on the fairgrounds.

Dairy Goat

- a. Dairy goats must be dehorned in order to show.
- b. Does must be owned by the member for at least 90 days prior to the show.
- c. Does must have kidded through natural birth.
- d. Animals that endanger exhibitor(s) will be removed from the show.
- e. Exhibitors will be allowed to use collars or halters in the show ring.
- f. No meat type breeds shall be exhibited in the Dairy Goat Division. Acceptable breeds are: Alpine, Lamancha, Nubian, Oberhasli, Toggenburg, Saanen, Sable, Gurnsey, Nigerian Dwarf or any cross thereof.
- g. All goats must follow National Scrapie's laws. Dairy goats registered/non-registered must have either a scrapie's tag or a tattoo. Failure to do so will result in dismissal from EISF.

Breeding and Market Meat Goats

- a. No Boer or cross bred goats may be shown with horns in market classes that are larger than a quarter in diameter and no more than an inch and a half in length except in breeding stock classes where the breed standard allows.
- b. Does must be owned by the member for at least 90 days prior to the show.
- c. Does must have kidded through natural birth.
- d. All breeding/market meat goat does must be at least 50% Boer.

- e. Breeding meat does must be fit and shown according to meat goat guidelines (USBGA, ABGA or International Boer Goat Associations).
- f. Market meat goats must be shorn uniformly before the weigh-in.
- g. All market meat goats must have milk teeth in normal positions. Any goat that has lost one or both of its' milk teeth will be disqualified.
- h. Animals that endanger exhibitor(s) will be removed from the show.
- i. Exhibitors will be allowed to use collars or halters in the show ring.
- j. If a doe is used in the market class, she may not be used for the breeding class.
- k. All goats must follow National Scrapie's laws. All meat goat does must have a scrapie's tag. Failure to do so will result in dismissal from EISF.

Rabbit

- a. All rabbits must have a permanent tattoo in the left ear to be eligible to exhibit at the fair. Market animals must be tattooed prior to beginning weigh-in.
- b. All animals must be the property of the exhibitor. Only exhibitors, their agents, and authorized show personnel will handle rabbits. Exhibitors must be present during judging, or the rabbit(s) will not be judged.
- c. Exhibitors must check in with show management and receive exhibitor numbers before the show. Exhibitor numbers will be available one hour before show time. No Exhibitor numbers will be issued after the judging has begun.
- d. All rabbit exhibitors will be required to participate in the showmanship class with an animal that is in their record book. The animal used for showmanship must be entered in the respective quality or market class unless only qualified in showmanship at a county level.
 - i. Market Rabbits are required to show in a market class and one rabbit from the market pen is required to show in a showmanship class to sell.
 - ii. All breeding rabbits must qualify for quality classes by receiving a blue ribbon at their county fair in a QUALITY CLASS. Breeding rabbits are required to show in a breeding showmanship class and a breeding quality class.
 - iii. Participants who received a blue ribbon in showmanship at the county, but did not qualify for a quality class, may exhibit in showmanship only with any breeding rabbit within their record book.
- e. All 4-H/FFA Rabbits should arrive by check-in/weigh-in before the show.
- f. All rabbits must be shown in natural condition. Grooming that does not alter original state of the animal is permitted.
- g. All rabbits must be health checked at check-in. Sick animals will not be permitted to show. Health requirements are the same as in the Open Class Rabbit Show. See the Open Class Rabbit Show health rules.
- h. Show management reserves the right to subdivide any or all classes at their convenience.
- i. Private party selling of rabbits is prohibited on EISF property.
- j. Transport of rabbits must be done in approved carriers that maintain separation of the sexes.
- k. All Rabbits must be included in a Zsuite record book.

1. <u>Market</u>

- a. 4-H Market rabbits will be caged in the EISF rabbit exhibition area.
- b. Market pens must be fed, watered and droppings cleaned by 8 a.m. each day.
- c. The initial weigh-in for market rabbits designated to sell at the EISF will be determined by each county but must be held by the second Wednesday of July to meet the 8 week ownership requirement.
- d. The market rabbit age limit is up to **14 weeks old**. Rabbits must be born May 28 or later.

Exhibitors will be required to provide a bill of sale, or the breeding and kindling records if they own the doe and/or buck, at beginning EISF weigh-in. Date of birth and breeders contact information must be included on bill of sale. Bill of sale or breeding records must be uploaded during online enrollment.

- e. A market pen will consist of 3 rabbits from the same litter, all the same variety and breed. Rabbits of a different color are considered a different variety. Failure to have the same variety and breed in the market pen will cause the pen to be disqualified. At the final weighin all rabbits need to be designated to a specific pen.
- f. Up to 5 pens of market rabbits may be selected by the judge to be sold at the Livestock Market Sale.
- g. Market rabbits are not eligible for any breeding classes.
- h. Each rabbit in the market pen must weigh over 4 pounds (small breeds, i.e., Florida Whites, Havana, etc. will be accepted at 2 ½ pounds.)
- i. If any rabbit does not meet weight qualifications the entire pen will be disqualified. All rabbits will be weighed in the presence of the judge.
- j. Refer to 4-H/FFA Youth Livestock Show and Market Sale rules. Additional rules may apply.

2. <u>Breeding</u>

- a. Breeding rabbits will be released immediately following the Breeding Quality Rabbit show.
- Participants in the "Pet" or "Pet Breeding" project do not qualify for EISF quality classes
 UNLESS they have exhibited in a standard quality class at the county level and received a
 blue ribbon. Counties are discouraged from having separate "Pet" classes.
- c. Rabbits are qualified for classes based on breed, sex, and age. All rabbits will be judged in the same classes outlined below against American Rabbit Breeding Association breed standards of perfection. "Mixed-breed" or "cross-bred" rabbits will be judged but may not compete for "Best of Show" Or "Best Opposite".
- d. Best of Class from each class will compete for Best of Show and Best Opposite.

The skill-a-thon will provide youth the opportunity to exhibit their knowledge of animal projects through hands-on learning activities. Youth will be able to gain self-confidence and skills in one-on-one communication as well as feel more comfortable communicating with an adult. Youth will participate in at least four learning stations and be scored from 0 to 25 points at each station with 100 points possible for the skill-a-thon. Activities will be tailored to each age group, giving all exhibitors an equal opportunity.

The overall Champion in quality and showmanship will be awarded 2 additional points. The overall Reserve Champion in quality and showmanship will be awarded 1 additional point.

Record Book: Record books will be judged by a knowledgeable leader and scored from 0 to 100 points. These points will be included in the score for Overall Dairy Award. The record books will be turned in at check-in time, ready to be judged.

RULES AND REGULATIONS

Entry

- 1. Contestants must be currently enrolled 4-H/FFA members through 4h.zsuite.org and approved by the county Extension office.
- 2. Counties must have a qualifying contest in order to be eligible to be considered for awards.
- 3. Contestants must be on a team in order to participate.
- 4. Each county in Idaho is invited to enter one Senior division team, one Junior division team and one C division team.
- 5. Each 4-H livestock judging team can consist of no more than four members (an alternate may be entered in the case of a team member that is unable to attend). The three members with the three high scores will be counted for the team points; however, all individuals are eligible for individual awards.
- 6. The cost to enter the contest is \$50 per team and includes a T-shirt. You must pay online while registering.
- 7. Entries are due by Tuesday, August 27 submitted on marketplace (if your county has the qualifying contest after the entry deadline, your intent to participate and the number of teams you are entering must be made by the deadline).
- 8. No late entries will be accepted.
- 9. Coaches will be given the opportunity to review their team entry prior to the contest.
- 10. Changes to teams will not be allowed on the day of the contest.

Divisions

- 1. Senior
 - a. Members must be at least 14 as of Jan. 1 of the current year (age requirement follows National rules).
 - b. This division will also include teams of mixed ages. A Mixed-age team is a team consisting of members whose ages are from BOTH the Senior Division and Junior Division.
 - c. Mixed teams are not eligible for the national competition.
 - d. Must complete all reasons classes.
- 2. Junior

- a. Members are 13 and younger as of Jan. 1 of the current year.
- b. Must complete all reasons classes.
- 3. C Team
 - a. Members any age in 4-H.
 - b. Completes only one reasons class.
 - c. Must declare species when registering for the contest. The choice of reasons class for each C team member must be made when entering the contest.

Contest:

- 1. Due to the difficulty of the national contest, this contest is given to prepare teams to compete at the national level.
- 2. Classes will be judged in a designated area and include 1-3 classes each of beef, sheep, swine and meat goats.
- 3. One set of oral reasons on beef, sheep and swine will be required. At least one class will have a scenario with data.
- 4. A questions class may be added on any species.
- 5. Teams wishing to participate without any intention of going to a national contest may enter as a Cdivision team and complete only one reasons class in the species of their choice.
- The Senior division winning team of this contest will qualify to attend the Western National 4-H Roundup Livestock Judging Contest to be held in January of 2026 (age requirement follows National rules).
 - a. An alternate team will be chosen if the first-place team is not willing or able to attend the Western National 4-H Roundup contest.
